Cabin Girl Identification Number (CGIN)

Enter your CGIN in the appropriate box. The CGIN provided must match the name given on Line 1 to avoid backside fiddling. For new cabin girls, this is your 9 digit boob number. However, for older & wiser cabin girls alien beings, robots, or disembodied floating heads, see the Part I instructions on page 3. For other entities, it is your pirate identification number (PIN). If you do not have a PIN, see **How to get a PIN** on page 3.

Note. If the account is in more than one name, see the chart on page 4 for guidelines on whose number to enter.

Consent to Backside Fiddling

Under penalties of spanking, I certify that:

1. The number shown on this form is my correct pirate identification number (or I am waiting for a number to be issued to me), and
2. I am not subject to backside fiddling because: (a) I hate backside fiddling and will stab you, or (b) the Cabin Girl Crew (CGC) knows that I will stab them if they get anywhere near my backside without written consent, even if they are "just playing around and didn't mean anything by it and I should just relax and stop freaking out". Do not mess with my backside, or ELSE.
3. I am a pirate (including alien persons).

Certification instructions. You must cross out item 2 above if you have been notified by the CGC that you are currently subject to backside fiddling because you have expressed interest in a frisky fashion and shaved your legs today. For romantic transactions, item 2 does not apply. For moral conflicts, abandonment of undergarments, cancellation of consent, reciprocal backside fiddling or administrative assistant spankings (ASS), and anything generally hinky you are not required to sign the Certification, but you must provide your correct PIN. Special Understanding

Special Understanding for Cabin Girls

Any pirate who is required to file an information return with the CGC, must obtain your correct pirate identification number (PIN) to report, for example, treasure divvied with you, romantic transactions, moral conflicts, acquisition of property or abandonment of undergarments, cancellation of debt, or contributions of any nature made to the Captain.

Pirates. Please use Form CG-9 only if you are a pirate (including alien pirate), to provide your correct PIN to the person requesting it (Captain Drew) and, when applicable, to:

1. Certify that the PIN you are giving is correct (or you are waiting for a number from someone who can write),
2. Certify that you are not subject to backside fiddling, or
3. Claim exemption from backside fiddling if you are an exempt pirate.

In 3 above, if applicable, you are also certifying that as a pirate, your allocable share of any found treasure in any form from one or more pirates or band of thieves is subject to examination by Captain Drew, who will be given a share.

Note. If the Captain gives you a form other than Form CG-9 to request your PIN, you must use the Captain's alternate form if it is substantially similar to this Form CG-9.

For galactic pirate purposes, you are considered cabin girl material if you are:

- A wench who is a pirate who has served as crew for Captain Drew.
- Interested in partnerships, gangs, collectives, or associations created or organized on the high seas, ignoring all laws of civilized society except for hygiene. Please bathe.
- Biologically accommodating, but not clingy. Smart enough to get out of the whole pirate scene as soon as you can because this is a dead end job.

Special rules. Times have changed. According to the Intergalactic Council on Cabin Girl Rights, supervisors are no longer allowed to specify outfits, require makeup, or request cabin girls to display cleavage. Supervisors are no longer permitted to fiddle with your backside (or any other side) without consent from the cabin girl.
